PERSONAL SUMMARY

I am an Associate Professor at the European School of Political and Social Sciences (ESPOL) in France, where I teach undergraduate and postgraduate courses on environmental governance and food/agricultural politics. As Master's Program Director, I oversee ESPOL's postgraduate degrees involving approximately 50 students and 15 lecturers. I am also a member of the Global Environmental Justice research group (University of East Anglia, UK), an interdisciplinary group of scholars interested in the linkages between social justice and environmental change. I hold a PhD in Political and Social Sciences from the Université catholique de Louvain (Belgium) on environmental justice and biodiversity conservation.

My research takes place at the intersection of environmental justice, governance and biodiversity conservation understood in its broadest sense (including biological conservation, ecosystem services management, agrobiodiversity conservation, land-use change, global biodiversity governance, and access and benefit-sharing of genetic resources). Recent publications include papers in *BioScience* (2019), *Nature Sustainability* (2018), *Capitalism Nature Socialism* (2018), *Biological Conservation* (2017 and 2016), *Journal of Rural Studies* (2016), *Journal of Agricultural and Environmental Ethics* (2015) and *Global Environmental Politics* (2015), as well as an edited volume published by *Brill/Martinus Nijhoff* (2015). I have also (co)authored several research reports on environmental policy for the European Commission, the Belgian government, and the UK House of Commons.
